Interest rate cut a plus for Queensland producers



Interest rates for the Queensland Government's First Start and Sustainability Loans have dropped for the second time in 2015, providing greater incentive for Queensland primary producers to expand or enhance their operations.

The new fixed interest rate for Productivity Loans drawn down from 1 July 2015 is 3.23 per cent for one year, 3.26 per cent for three years and 3.45 per cent for five years.

QRAA Chief Executive Officer, Cameron MacMillan, said agriculture played an integral role in the Queensland economy and the interest rate drop will help primary producers take proactive steps to build the capacity of their enterprise.

"Sustainability Loans allow producers to invest in projects such as property expansion, improved water infrastructure, predator fencing, efficient irrigation systems and energy saving equipment," he said.

"These loans can also be accessed to assist producers wanting to protect their farms from biosecurity risks or to fund infrastructure improvements," Mr MacMillan said.

Current for loans drawn down from 1 July 2015 and subject to change 1 January 2016.

Mr MacMillan also encouraged anyone looking to start their own farm business to take advantage of the lower interest rates

"QRAA is proud to support aspiring Queensland farmers who are looking to acquire their first farm or become part of the family farm through First Start Loans," he said.

Primary producers can access loans of up to \$650,000 with no fees or charges and repayment terms of up to 20 years.

Farm businesses also have the option of using joint lending with commercial banks if they need additional finance beyond the \$650,000.

During the 2014-15 financial year, QRAA approved over 160 First Start and Sustainability Loans, worth more than \$51 million to Queenslanders.

"I strongly urge any producer who is looking to apply for a Sustainability or First Start Loan not to self-assess," Mr MacMillan said.

"QRAA's Client Liaison Officers are available to meet on-farm to discuss loan criteria, terms and conditions. They can also provide expert advice on the best way to prepare your application."

Primary producers, small businesses and non-profit organisations that were affected by this natural disaster event are encouraged to review the guidelines and application forms on QRAA's website and submit an application before the closing date.

Applicants must be located in an eligible Local Government Area.

First Start Loans support succession

QRAA provide the ideal starting point for farming businesses considering succession.

These loans can support the viability of a farm business which is one of the biggest factors in ensuring that a farm will be available for the next generation.

QRAA's First Start Loans offer concessional finance that can help the next generation move into farming.

Low interest rates combined with no fees and charges enhance an enterprise's ability to establish a solid platform from which succession can occur.

Over the past five years QRAA has approved over \$157 million to 396 individuals or partnerships who are entering primary production or aiming to become full-time viable primary producers through staged progression.

Productivity Loans available through QRAA's Customer Relations Manager, Craig Turner, said he believed these loans were instrumental in helping the next generation.

> "When it comes time for the next generation to become involved in the farm, QRAA can assist with succession in a number of different ways," he said.

> "There are options to finance the next generation into the existing farming partnership, providing funds to buy their first property with a view to a more viable operation upon succession occurring. This can also be done by financing applicants into a newly established family partnership," Mr Turner said.

A practical example

Anext generation beef producer from Roma, who has built up his own herd of 200 cattle, accessed a First Start Loan of \$300,000 to purchase a portion of his parent's property at a discounted purchase

His plan over the next five to 10 years is to continue to increase his cattle numbers and to build equity, whilst working off-farm for wages. In time, he will seek a further First Start Loan to purchase the remainder of his parent's property, stock and plant.

He will end up with a viable primary production enterprise and his parents can retire comfortably, knowing the farm is in good hands.

Top marks for QRAA's customer service
