ATO ASSISTANCE FOR TAXPAY

With drought conditions affecting many parts of Australia, the ATO is highlighting their support options for those affected. Tailored assistance options are being offered to help drought-affected businesses & individuals who are experiencing financial difficulty. ATO Deputy Commissioner Steve Vesperman is encouraging drought-affected taxpayers to talk to the ATO now so they can figure out a plan that works for

"If you're having difficulty managing your tax obligations we can help get you back on track," said Mr Vesperman, "We can create tailored payment plans & offer tax bill & lodgment extensions.

The ATO are also reminding primary producers that accelerated depreciation is available. Primary producers can

now immediately deduct the cost of new fencing & water facilities, and take advantage of accelerated three-year depreciation of capital expenditure on fodder storage assets.

There are also special provisions to help primary producers manage an uneven income flow.

- Tax averaging enables you to even out your income & tax payable over a maximum of five years to allow for fluctuations. Call 13 11 42 (option 3) to set up a tailored payment plan or request an extension of time to pay tax bills and make
- Use the farm management deposits scheme and make tax deductible deposits during prosperous years that you can later draw on.
- Special rules apply to some unusual income you may receive such as disaster relief payments, grants and subsidies.
- You can <u>claim your primary production losses</u> immediately against other income if you are a sole trader or in a partnership, and your assessable income from other sources is less than \$40,000 (excluding any net capital gain).

"The income tax rate for small business companies has been reduced from 30% on all taxable income to 28.5% for income years starting on or after 1 July 2015," said Mr Vesperman. "Individuals with income from a small business may also be eligible for a 5% tax discount.

"Don't forget that small businesses with an annual turnover of less than \$2 million can instantly write -off assets up to \$20,000 & they can apply this rule to as many individual items as they wish." he said.
